## Use Guidelines for Digital Reproduction

The staff of the Map Collection will arrange for digital reproduction of non-circulating materials in the Collection under the following conditions. This form must be signed at the time the order is placed; in so signing, the user indicates an understanding of and agreement with the conditions outlined below.

### Conditions of Reproduction

1. Reproductions will be handled through the University of Washington Classroom Support Services.
2. Reproduction may be refused in cases of donor restriction or copyright law violation.
3. The user assumes full responsibility for any infringement of copyright and for publication rights of reproduced materials.
4. Reproductions may not be further duplicated for sale or for subsequent use without specific agreement and the payment of any applicable fees.

### Credit Line and Copies Required

5. An appropriate credit line must be given in all cases of publication, exhibition, presentation, or any other display of reproductions from the Map Collection. Credit line should read *Map Collection and Cartographic Information Services, University of Washington Libraries*.
6. One copy of any publication that uses reproductions from Map Collection materials shall be donated to the University of Washington Libraries. This shall include books, brochures, advertising materials, periodical issues, exhibition catalogs, and videotape productions; but shall not include motion picture films.
