BIOGRAPHY

Arthur Barnett was the Seattle attorney for the noted painter, Mark Tobey, beginning in the 1940's and continuing until Tobey's death in 1976. Barnett handled Seattle matters for Tobey after the artist moved to Basel, Switzerland in 1960 and served as executor for Tobey's estate.

SCOPE AND CONTENT

The bulk of the accession consists of Tobey's papers, primarily correspondence, writings, financial records and photographs of art works, 1928 to 1985. The writings, notebooks and a few other items are photocopies. The originals may be in the Mark Tobey papers. The accession measures .63 cubic feet.

ADMINISTRATIVE INFORMATION

The Barnett papers were processed in 2000. During processing many photocopies were matched with originals in the Tobey papers and were discarded. The papers were donated to the Libraries in 1999 by Arthur and Virginia Barnett.
